1. Sound Exchange:

- a. Q4 2020 marked incomplete (Fred submitted the wrong streaming file).
- b. Q1 2021 period was 2/14-27/2021. Reporting in-process.

2. Facilities:

- a. HVAC replace / furnace draft motor issue / hot water heater: Pending bids.
- b. The front door battery tray corrosion: Pending cleaning.
- c. Front door water in airlock during rainstorm: Pending adjustment.
- d. Bathroom vent fan: Pending install.
- e. Sprinkler system inspected, fixes will be done 3/9/21.
- f. Station security:
 - i. Front door lock: Pending adjustment.
 - ii. Improved lighting: Installation completed.
 - iii. Motion detector / Intercom / Code: TBD if needed.

3. Engineering / IT:

- a. Bob stepped down from IT support role effective 7/10. Dave Vollenweider, a new volunteer is able to assist with IT tasks.
- b. The new antenna iced up during the ice storm, which has lasted several days, resulting in loss of most of the transmission power and a noticeably degraded signal. Options under consideration.
- c. Signal static heard over several days in February. Bob checked this at the transmitter site, and determined that the source is somewhere in the signal chain from the studio to the Lincoln building to the transmitter receiving end. Monitoring equipment has been installed.
- d. Transmitter powered down 3/1. No apparent cause.
- e. Motor-boating noise still there, no change. Not a priority.
- f. No Recording / Streaming computer / CDs: No major issues.
- g. Dave is investigating re-use of old computer systems.
- h. Studio monitor replaced with donor monitor.
