PC working on:

Due to Covid-19 considerations, the PC has been conducting meetings via Zoom. The PC was able to meet regularly during Q3 (no quorum issues).

Airshifter tracking tool – reminder emails went out to any Airshifter that has not attended two Associates' meetings in the past year (20 Airshifters) and all Airshifters in arrears with their membership dues (7 folks) on Aug 28 (24 meeting/4 dues prior to June 2 meeting). AEC (Bill Wolfe) is working to develop a new mechanism to notify Associates of requirements.

FCC Classroom training was held via Zoom on May 18-10 participants. One trainee has completed his training and recently subbed a Friday afternoon Global Music show. Next classroom training will be held on Oct. 5 via Zoom. PSA on the board and in the Dropbox soliciting trainees and on-air talent.

PC is working on an email/letter to community members (U of I School of Music, Urbana Schools, Champaign Public Library, etc.) to gauge any interest in WEFT and the possibility of sending new members/on-air talent WEFT's way. Also considering reaching out to past on-air

WEFTies to see if there's any interest in collective/weekly/monthly show.

Also, please wrap up your show and depart the booth at the scheduled end of your airshift. Financial Development Committee:

A grant Proposal for \$7600 was submitted to the CFECI on Monday. The grant Report for IAC is due this month. As bob mentioned I still need to write a pre-drive letter. Pledge Drive starts on Sept.

Jet Sterling assisted WEFT in getting a billboard again this year. Thanks to Edwin Hadley for another great design. This will go up in a week or two at 100 E Springfield Ave.

WEFT Fest is scheduled for Sunday, Sept 26 from 2-6 – which is the actual date of our 40th anniversary.. I sent out an email today expressing my concern about moving forward with WEFT Fest after reading about the spike currently happening in Champaign for vaccinated people. Apparently more vaccinated people than unvaccinated have tested positive in recent days. I spoke with Julie Pryde earlier as well. She said that as long as we were outdoors, being masked and socially distanced it should be okay. Most infections of vaccinated folks are coming from being at indoor events unmasked. Given that, what are thoughts on having or delaying WEFT Fest?

We need many volunteers to pull this off safely for all. We need volunteers for set-up (noon-2) and tear down (6-8), manning a merchandise table, collecting donations, selling raffle tickets, greeting guests and signing people up for memberships and donations, making announcements, and possibly assisting Mike with the stage area set-up and broadcast. We also need show hosts to man the booth during the spaces between bands. This cannot be left to a handful of volunteers, and if we don't have enough, we may have to cancel anyway.

We also need assistance on requesting raffle items. The FDC wrote a letter for that purpose, and so far it has been pretty effective. We have donations from Krannert Center, OLLI, Columbia Street Roastery, a guitar from PCBS, guitar lessons with Ryan Groff, and some very cool WEFT tote bags made by Lorri Coey. A late addition arrived today from the Folk and Roots Committee – 2 t-shirts and wristbands for the October Festival. We definitely need more though. Anyone who knows a business or organization who might donate can contact them directly or let me know.

Finance Committee

The finance Committee develops the annual WEFT budget. Our fiscal year starts on Oct 1, so the budget will be voted on by the board at the September board meeting. The most notable change is funding a part-time position for a station manager in 2022. If that passes, a search committee will be established to write a job description, read resumes and interview candidates, probably after the first of the year.

RAT (Remote Access Team) Report

As of Aug. 24, 14 shows per week were being home-produced and 36 shows per week were being produced in-studio. The balance of 28 shows per week was being covered by RAT member remote operations (Courier/Informational programming/Zara).
