7:26 **Station Manager's Report**

Eric Bohlen (Station Manager) reported that the adjacent building (nee Monk's) is on hold with city and power company issues, but still plan to have retail space plus an apartment. The coming weekend is the last "The Beat" entertainment district with Friday Nite Live. Next year is the 50th Anniversary of Prairie Air, Inc.; there were several years of planning before WEFT's first FM broadcast, including providing audio feed for cable channel and UofI dorms. There is a WEFT smartphone app in development. Spinitron is offering playlist automation. WEFT is working with two Uofl student groups; Office of Experiential Learning, who are trying to identify actual listenership. Also a group associated with the American Advertising Federation to help with promotions.

7:35 **Board of Directors Report**

Vicki Niswander (Board Chair) reported that there are two new member-elected board members: Mitch Marlow, and Donte Winslow.

7:36 **Treasurer's Report**

Mark Niswander shared his treasurer's report and went over balances, income and outlays for the quarter. Gina Pagliuso asked about Smile Politely payments, which are for promotions; Vicki reports that half of recent trainee group learned of WEFT from Smile Politely.

7:43 **Governance and HR Committee Reports**

Vicki Niswander reported that the revised by-laws effort is moving slowly and needs review. She needs to post the very long document that compares current by-laws to the proposed. No HR report.

The Station Manager got some pro radio engineers to visit the transmitter site and take measurements to advise on the static issue; Paul Mueth asked about this versus our aging Optimod (FM Multiplex generator), and there was an extended discussion of the technical issues.

8:12 **Financial Development Report**

Vicki Niswander reported about the WEFT Fest plan with help from Seven Saints, four bands, some city funding, and the street setup. That kicks off fall fund-raising drive. The Underwriting flier was revised, and Eric is working to get new underwriters. A grant proposal was submitted to the Community Foundation to get a new Optimod. They are also planing a grant request for new STL when the new hotel blocks the microwave link.
