7:02 Call to Order

Evelyn Underwood (Chair) called the meeting to order.

7:03 Introductions

Evelyn introduced herself then called attendees to do so. We had quorum.

7:22 Approval of the Agenda

Kevin Elliott moved to approve the agenda; Rich Bressler seconded; approved.

7:23 Approval of the Minutes

Jeff Zolitor moved to approve the 04 December 2024 draft minutes; Todd Hunter seconded. Some corrections were offered; approved as amended.

7:27 Reports

7:27 Station Manager's Report

Eric Bohlen (Station Manager) asked for email from those who actually uses the CDs in the Great Hall, since the Music Committee is planning some adjustments to the shelf space.

The WEFT listening app had 315 users with an average of 25 sessions per day split 50-50 between the live stream and listening to archived shows, which can be found from the show grid.

Eric reported that this summer will be busy for Outreach - Boneyard Arts Festival, Wine Walk, Friday Nite, and the other events where WEFT has a table. Eric continues to work with University of Illinois class projects in Marketing and Advertising, such as producing a 'zine about WEFT, and adding TikTok engagement.

2025 is Prairie Air, Inc.'s 50th Anniversary which is a promotional theme.

Eric is getting quote for Tower Climbers to replace damaged 300' feed line. Instead of a Spring Pledge Drive we plan a focused campaign to cover the estimated \$20K to \$50K "Power to the Tower".

7:40 Board of Directors Report

Audrey Fisher (Board Chair) reviewed the Bylaws refresh status; Vicki Niswander (Board Vice-Chair) mentioned there is a shared folder now that has a comparison between current and proposed bylaws, so that interested parties can review and comment.

7:46 Treasurer's Report

Mark Niswander shared financial spread sheet and mentioned WEFT has total assets of \$351K but is running a \$64K per fiscal year deficit budget: \$160K out vs. \$100K in; that's \$19/hr to operate the station. There were a few questions about specific items.

7:56 Governance and HR Committee Reports

Governance was covered in the board report, and there is no HR report.

7:57 Programming Committee Report

Gina Pagliuso submitted a PC reported. See attached report below. There are some programming changes including a new drop-in "Good News, Good Planet", and some one-off specials. Airshifter Training is in planning. The PC sends email reminders about schedule changes and operational rules, and sends individual reminders about dues which prompted some discussion.

8:07 Music Committee Report

Anthony Santarelli gave a thank-you to Eric for clearing a logjam in the CD shelving space, and cleaning up the attic space. There was a question about joining the MC and how to find the meetings.

8:12 Digital Library Report

Bob Paleczny shared a written DL report, see below.

Bob mentioned we are entering another Sound Exchange reporting period, where we turn on the Spinitron end-time field. We've instituted Zara Automatic Music Recognition which means that Zara spins are now reported. Now Aggregate Tuning Hours are over 2100 where previously they were 1500-1600.

The front mixing board has had partial crashes a few times requiring it to be power-cycled. The new Optimod FM processor is installed in the Great Hall equipment rack but switching over from the old Optimod is pending repair of the transmitter / antenna feed line.

DL committee is consider changing the "collecting" computer in the basement to a Great Hall computer.

The tower climbing team checked the connection from the feed line to the antenna and that checked out OK, so we don't need to replace the antenna. Also, they can install a new feed cable with needing a crane.

8:21 Financial Development Report

Vicki Niswander reported that they are preparing a campaign letter to support the transmitter repair. Vicki is preparing an Illinois Arts Council grant proposal, and solicited summaries of any artist interviews air-shifters may have done.

8:23 Remote Access Team Report

Gina Pagliuso provided a written report (attached below) and said that remote operations have been stable recently.

8:24 Community Outreach Report

Todd Hunter reported that the Outreach committee activity will pick up in the summer when WEFT can have information tables. Eric Bohlen mentioned that Goodie Bags has been a successful effort getting new listeners and volunteers. Gina asks if there is a list of events that volunteers can help with.

8:30 Comments

No comments or question prior to voting.

8:31 Voting

There are no open Programming Committee seats, three open Board of Directors seats, and all five seats open on Associates Executive Committee. We continue to vote by Zoom private message to Vicki Niswander, the Zoom meeting host. Vicki described explained how to run through the board.

8:32 Voting - Board of Directors

Bob Paleczny and Barbara Trumpinski-Roberts Associate-elected odd-year terms are expiring, and and additional odd-year seat is open. Vicki nominates Barb and Bob. Bob Paleczny accepts, but for an open even-year seat, thus for a 1 year term; Barbara Trumpinski-Roberts accepts for a 2-year term.

After some questions about board member duties and meeting frequency, Kaitrin Higbee nominates herself. Todd Hunter moves to close nominations, Gina Pagliuso seconds.

The candidates make statements, accept questions and endorsements. Vicki describes how to vote.

8:45 Voting - Programming Committee

There are no Associate-elected PC seats open. Vicki explained how to run through the board.

8:46 Voting – Associates Executive Committee

All five AEC seats expire in March, including the Chair, Secretary, and three at-large seats. Mike Feldman nominates himself to continue as Secretary. Evelyn Underwood explains she was Chair for just a year, and would continue but as an at-large member. Zack Widup would continue as an atlarge member, but can't commit to serving as Chair. Gina offers to nominate Todd Hunter and Ben Theobald; Ben accepts and Todd declines.

Continuing the AEC nominations, Evelyn talks Ben into standing for Chair. Todd nominates Dave Vollenweider for and at-large seat, and Dave accepts as long as he's not Secretary.
